

AGREEMENT

THIS AGREEMENT made on the 31st day of July 2018 between the MUNICIPALITY OF SAN LUIS, PHILIPPINES (hereinafter called the "the Entity") and BEE ELECTRONICS, INC with office address at 3rd Floor Sto. Domingo Bldg, 8483 Kalayaan corner Gloria St., Makati City (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited bids for certain goods and ancillary services, viz., PROVISION AND INSTALLATION OF MUNICIPAL UNIFIED COMMUNICATION SYSTEM under Contract Reference No. 5494635 and has accepted a Bid by the Supplier for the supply of those goods and services in the sum PESOS : FIVE HUNDRED NINETY EIGHT THOUSAND NINE HUNDRED AND 00/100 (PHP 598,900.00) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meaning as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz:

(c) the Technical Specifications;
(d) the General Conditions of Contract;
(e) the Special Conditions of Contract; and
(f) the Entity's Notification of award
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the contract
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract
