

AGREEMENT

THIS AGREEMENT made on the 17th day of January 2019 between the MUNICIPALITY OF SAN LUIS, PHILIPPINES (hereinafter called the "the Entity") and P.M. Zarate Agri Enterprises with office address at Estipona, Pura, Tarlac (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited bids for certain goods and ancillary services, viz., SUPPLY/DELIVERY OF MULTI-SHREDDER/PULVERIZER FOR NON-BIODEGRADABLE WASTE under Contract Reference No. 5925202 and has accepted a Bid by the Supplier for the supply of those goods and services in the sum **PESOS : SIX HUNDRED FIFTY THOUSAND AND 00/100 (PHP650,000)**. (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meaning as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz:
 - (a) the Bid Form and the Price Schedule submitted by the bidders;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the General Conditions of Contract;
 - (e) the Special Conditions of Contract; and
 - (f) the Entity's Notification of award
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the contract
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract
